HOW TO ORDER

FIREARMS:

Agency purchase: A completed FET tax exemption form, sales tax exemption certificate and simple agency letter indicating the purchase is for agency use and not for resale.

Personal purchases: Follow the instructions on the personal purchase program.

ACCESSORIES:

Agency purchase: A simple agency letter for agency purchases indicating purchase is for agency use and not for resale.

Personal purchases: A legible copy of the front and back of your Drivers License and the front and back of your Federal or State Issued ID and credentials should be submitted with your payment and a completed CMC order form.

Benelli Personal Purchase Program

Qualified purchasers for the personal purchase program must be active sworn law enforcement officers and have legal arrest power within their jurisdiction:

- All sworn Law Enforcement Officers, including federal, state, county and city

Due to US firearms laws regarding imported shotguns and specific imported firearm options & accessories, the Benelli Law Enforcement models can only be sold to active LAW ENFORCEMENT officers. Unfortunately, we cannot sell Benelli products to any other type of purchaser, regardless of your qualification under any other program.

Accessory Only Ordering:

If you are not ordering a firearm, all you need to do is return the completed order form with your payment, a legible copy of your Driver's License and the front and back of your State Police Commission ID. You can send it to us via regular US Mail, FedEx or UPS overnight, FAX it to (214) 889.5180 or scan & email it to us at orders@cmcgov.com. **To avoid order processing errors, we must receive all paperwork together. We cannot match paperwork submitted separately.**

Firearm Ordering Option 1 – Ship to Agency:

IF YOU ARE A LAW ENFORCEMENT OFFICER AND YOU LIVE IN THE STATES OF CALIFORNIA, MARYLAND, MISSOURI, NEW JERSEY, PENNSYLVANIA, OR VIRGINIA, YOU SHOULD DISREGARD THIS SECTION and use Option 2.

You can submit a completed order form with your payment, a legible copy of the front and back of your Drivers License and the front and back of your Federal or State Police Commission ID and an original signed Purchase Authorization Letter (see attached sample PAL) signed by you and a department designated person of authority (POA) on official department letterhead, and we can ship your firearm directly to you at your official department address. No additional paperwork is required. **DO NOT FAX DOCUMENTS TO US. WE NEED ORIGINAL COPIES AND SIGNATURES for ALL DOCUMENTS.**

Firearm Ordering Option 2 – Ship to a FFL Dealer:

You can submit a completed and signed order form with your payment, a signed copy of your firearms dealers' FFL, a legible copy of the front and back of your Drivers License and the front and back of your Federal or State Issued ID and credentials. The process is simple:

1) Locate a gun store we can ship your firearm purchase to. Get a clean, legible signed copy of their current Federal Firearms License. We can only ship your purchase to the address on the FFL. Some FFL dealers may prefer to send us their FFL directly. This is OK, provided they also send us all of the order documents together, their signed FFL, a copy of your ID, credentials and completed order form with payment. **To avoid order processing errors, we must receive all paperwork together. We cannot match paperwork submitted separately.**

2) Complete and sign the attached order form.

3) Return the completed order form with your payment, a legible copy of your Driver's License and the front and back of your State Police Commission ID and a signed copy of your local gun dealer's signed FFL to us and we will process and ship your order to the dealer for delivery to you. You can send it to us via regular US Mail, FedEx or UPS overnight, FAX it to (214) 889.5180 or scan & email it to us at orders@cmcgov.com. **To avoid order processing errors, we must receive all paperwork together. We cannot match paperwork submitted separately.**
