## HOW TO ORDER

### OPTION 1 - Sworn Law Enforcement Officers Only:

IF YOU ARE A LAW ENFORCEMENT OFFICER WHO WISHES TO ACQUIRE HIS OR HER FIREARM THROUGH A FEDERAL FIREARMS LICENSEE RATHER THAN THROUGH YOUR LAW ENFORCEMENT AGENCY **OR IF YOU LIVE IN THE STATES OF CALIFORNIA, CONNECTICUT, MARYLAND, MISSOURI, NEW YORK, NEW JERSEY, PENNSYLVANIA, OR VIRGINIA, YOU SHOULD DISREGARD THIS SECTION and go to option 2.**

**MAKE SURE THE SPECIFIC FIREARM AND MAGAZINES YOU WANT TO PURCHASE ARE LEGAL TO OWN IN YOUR AREA. Once a firearm has been ordered and assigned to you they cannot be returned.** Most local licensed firearms dealers can advise you. CMC cannot tell you if any of the Sako or Tikka firearms are legal to own anywhere in the United States except for Texas.

You can submit a completed order form (attached) with your payment, a legible copy of the front and back of your Drivers License and the front and back of your Federal or State Police Commission ID, an original signed Individual First Responder or Military / Federal Officer Verification form (attached) and an original signed Purchase Authorization Letter (see attached sample PAL) signed by you and a department designated person of authority (POA) on official department letterhead, and we can ship your firearm directly to you at your official department address. No additional paperwork is required. **DO NOT FAX DOCUMENTS TO US. WE NEED ORIGINAL COPIES AND SIGNATURES for ALL DOCUMENTS.**

**OPTION 2 - Any qualified purchaser listed above, including sworn law enforcement officers:**

You can submit a completed and signed order form (attached) with your payment, a signed copy of your firearms dealers FFL, a legible copy of the front and back of your Driver's License, an original signed Individual First Responder or Military / Federal Officer Verification form (attached) and the front and back of your Federal or State Issued ID and credentials. **DO NOT FAX DOCUMENTS TO US. WE NEED ORIGINAL COPIES AND SIGNATURES for ALL DOCUMENTS.**

Federal law requires us to transfer this firearm to a Federal Firearms Licensed dealer in your area for delivery to you. Most pawn shops or local gun stores will provide this service to Law Enforcement free or for a small fee to process the paperwork and background check as required by law.

The process is simple:

**1) MAKE SURE THE SPECIFIC FIREARM AND MAGAZINES YOU WANT TO PURCHASE ARE LEGAL TO OWN IN YOUR AREA. Once a firearm has been ordered and assigned to you they cannot be returned.** Most local licensed firearms dealers can advise you. CMC cannot tell you if any of the Sako or Tikka firearms are legal to own anywhere in the United States except for Texas.

2) Locate a local pawn shop or gun store we can ship your firearm purchase to. Get a clean, legible signed copy of their current Federal Firearms License. We can only ship your purchase to the address on the FFL. (Make sure you send us a copy of their FFL that has been signed by the same person who signed the original FFL. **DO NOT SEND A COPY OF THE SIGNED FFL. WE MUST HAVE AN ORIGINAL SIGNATURE ON THE COPY OF THE FFL.** Some FFL dealers may prefer to send us their FFL directly. This is OK, provided they also send us a copy of your ID, credentials and other required documents with it. You can send it to us via regular US Mail, FedEx or UPS overnight or email it to us per the instructions below. **DO NOT FAX IT TO US. WE NEED ORIGINAL COPIES AND SIGNATURES for ALL DOCUMENTS.**

3) Complete and sign the attached order form.

4) Return the order form with your payment, a legible copy of your Drivers License and the front and back of your State Police Commission ID and a signed copy of your local gun dealer's signed FFL to us and we will process and ship your order to the dealer for delivery to you. **DO NOT FAX IT TO US. WE NEED ORIGINAL COPIES AND SIGNATURES for ALL DOCUMENTS.**
